IMPLEMENTATION OF THE AMENDED SENIOR CERTIFICATE, A QUALIFICATION FOR ADULTS AND OUT OF SCHOOL LEARNERS

#### 1. BACKGROUND

- 1.1. The last Senior Certificate Examination based on the policy document, <u>A Resume of instructional programmes in schools (Report 550)</u>, which allowed learners with incomplete Senior Certificate credits, as well as adult learners with incomplete Senior Certificate credits, as well as adult learners of 21 years and older, was conducted in June 2018.
- 1.2. Based on the need for a qualification for adults that are equivalent to the current National Senior Certificate (NSC), the Minister of Basic Education has approved the revision of the current Senior Certificate qualification such that it can be offered by learners who will have no alternative route to follow, post June 2014. The amended Senior Certificate retains its qualification structure but will utilize the National Curriculum Statement (NSC) subjects to support the qualification.



1.3. This implies that the Curriculum and Assessment Policy Statement (CAPS) subjects will be offered as part of the amended Senior Certificate that will be written in June / July 2020. All Senior Certificate subjects that were passed prior to June 2017, at Higher Grade and Standard Grade levels, excluding Lower Grade conversions, will be recognized.

#### 2. WHO QUALIFIES TO WRITE THE AMENDED SENIOR CERTIFICATE?

The following learners will qualify for admission to the amended Senior Certificate

- a) Adult learners who are 21 years and older who have:
  - i. A General Education and Training Certificate (GETC); or
  - ii. A Grade 9 school report (or the old standard seven), stating that they have passed Grade 9 or Standard 7; or
  - iii. A recognized equivalent qualification obtained at NQF Level 1 which requires two official languages
- b) Adult learners who are 21 years and older with an incomplete National Senior Certificate qualification.
- c) Adult learners who are 21 years and older with an incomplete National Senior Certificate and whose School Based Assessment (SBA) validity has expired.
- d) Only in exceptional cases, out of school youth, who are 18 21-year-old and who could not complete their school education due to circumstances beyond their control, as verified and approved by the Head of Department in the Provincial Education Department.

#### 3. SUBJECTS TO BE OFFERED

The subjects listed below which are part of the Curriculum and Assessment Policy Statement of the National Senior Certificate, will be offered as part of the amended Senior Certificate. The subjects will in essence be the Curriculum and Assessment Policy Statement of the National Senior Certificate, excluding the School – Based Assessment (SBA) component. Each candidate must offer six subjects in order to qualify for the amended Senior Certificate. Adults who have approved Senior Certificate subject credits, but do not comply with the required six subjects' package, must select the remaining required subjects from the following list of 14 adapted National Senior Certificate subjects:

# 4. SUBJECTS TO BE RECOGNISED

Senior Certificate subject credits that were passed prior to June 2014, at Higher Grade and Standard Grade levels, excluding Lower Grade conversions, will be recognized.

With the exception of Business English N3, Second Language, and / or Sakeafrikaans N3, Second Language, no N3 subjects will be recognized. In the case of learners, who have attempted the National Senior Certificate Examination, but were unable to complete all the subject requirements, and have exhausted the three-year validity period allowed for the School Based Assessment (SBA), such candidates will have all their previous credits recognized.

#### 5. EXAMINATIONS

- Candidates that qualify to write the amended Senior Certificate Examinations will write the examination in June / July 2021. Candidates writing the amended Senior Certificate will be exempted from School Based Assessment, and this implies that the examination in the subject will constitute 100% of the final mark.
- Examinations will be administered at designated examination centres determined by the District Education Department.
- The examination may also be offered by the independent assessment bodies accredited by Umalusi.



# 6. REGISTRATION FOR THE 2021 SENIOR CERTIFICATE EXAMINATION

Adults who qualify to write the 2021 amended Senior Certificate Examination must register for the examination not later than **29 January 2021**. Learners may register at any District Education office or Circuit Office. The Registration form that needs to be completed by candidates is attached as **ANNEXURE A**.

# 7. PREPARATION FOR THE 2021 SENIOR CERTIFICATE EXAMINATION

Learners that intend to write the 2021 Senior Certificate Examination must commence with preparation for the examination immediately, given that the curriculum is a programme. Learners may obtain the Curriculum and Assessment Policy Statement (CAPS) for the relevant subject from DBE website or the nearest Provincial Education Office. Exemplar question papers based on CAPS are available on the DBE website: <a href="https://www.education.gov.za">www.education.gov.za</a> / examinations.

#### ANNEXURE B

# Senior Certificate (amended) - Promotion Requirements and Combinations

- 1. Promotion Requirements for candidates offering only amended SC subjects and combination of SC(a) and NSC subjects
  - a) Pass at least five of the six SC(a) subjects.
  - b) Pass three subjects at 40% and two at 30%.
  - c) Obtain a <u>sub-minimum of 20%</u> in the sixth subject.
  - d) Pass two languages, one of which must be at HL level at 40% and the FAL or another HL at 30%. No FAL will be offered and can be considered.
  - e) One of the languages should be a LOLT language.
  - f) One subject condonation (max 2%) at 40% or 30% or 20% if the candidate is short of one subject to obtain the qualification. Condonations should be calculated on marks and not on percentages.
  - g) No aggregate requirement for candidates taking all amended SC subjects.
  - h) Language compensation will be applied only to full package candidates.
  - i) No immigrant concession will be granted.

#### 2. Credits that will be recognised

- a) <u>Senior Certificate HG subject</u> passed prior to June 2015 at 40% (max 400) (exception second language HG at 33.3%, max 300).
- b) Senior Certificate SG subject passed prior to June 2015, at 33.3% (max 300).
- c) No LG credits will be recognised, except a SG subject converted to LG when needed to affect a pass and then only one LG will be considered when a 6<sup>th</sup> failed subject is needed.
- d) Sakeafrikaans or Business English on First or Second language level passed at 40% (max 300).
- e) SC(a) subjects offered in June 2015 and thereafter, passed at 30% (max 300).
- f) NSC subjects passed at 30% (max 300).
- g) <u>Life Orientation</u> will be excluded from any combinations and calculations.
- h) All subjects to be <u>converted to a maximum of 400</u> for combination purposes.
- i) One failed credit from another qualification can be considered if that is the only subject needed to complete a full package of 6 subjects. To pass, the subminimum of 20% applies.
- j) A-level language subjects will not be accepted.

#### 3. Principles for Combination

- a) A candidate may combine any number of previous credits from the SC (a) or SC or NSC or N3 languages.
- b) Only subjects that have been passed will be utilised for combination purpose. One failed subject will be recognised.
- c) A candidate must pass 5 subjects.

- d) Best 6 subjects will be used for combinations. When 2 subjects to be used got the same mark, subjects should be used in this order: SC (a), NSC, SC and then N3.
- e) If they got the same mark, <u>Mathematics</u> will always be used before <u>Mathematical Literacy</u>.
- f) In the case of converted subjects from HG to SG the real/certified mark will be utilised.
- g) Only <u>HG subjects converted from an F to an E</u> will be accepted. HG subjects converted from a FF or G will not be accepted, except if it used for the sixth subminimum subject.
- h) A converted subject can be condoned when it can lead to a pass.
- i) A candidate must offer a minimum of one SC (a) subject and that SC (a) subject must be passed at 30%.
- j) The <u>subminimum requirement of one subject at 20%</u> will apply to all candidates including those requesting combinations.
- k) All six combination subjects including the one <u>failed subject</u> (where applicable) should be reflected on the Statement of <u>Results as well as the Confirmation Letter</u>. Although the certificate will only reflect the "pass"-subjects as per Umalusi policy.
- 1) In the combining of results, the pass as stipulated for that subject in the specific qualification must be satisfied.
- m) Aggregate of 800 will only apply in the case of combination of amended SC with old SC subjects and N3 languages.

  No aggregate will apply for combination of SC (a) with NSC use same rules as candidate taking all SC (a) subjects.

  An immigrant status cannot be transferred from a previous exam sitting.
- n) A candidate can receive <u>only one condonement</u>, either an aggregate condonement or a subject condonement (in this order).
- o) <u>Similar subjects from different qualifications</u> cannot be used in combination of results as per policy, e.g. Biology and Life Sciences; English HL/FAL and Business English; etc.
- p) Only N3 Language subjects from 2001 will be used for combinations.

#### 4. Promotion Requirements for Combinations (Rules)

- a) Present six subjects or more.
- b) Pass at least five of the six subjects.
- c) Pass at least one SC (a) subject at 30%.
- d) The <u>best six subjects</u> including the best two languages (one must be HL or 1<sup>st</sup> language) will be taken into consideration.
- e) Pass two languages, one must be on the level of Home Language/First Language/A-Language at 40% and the other on the level of First Additional Language/Second Language/B-Language at 33.3%/30% this includes N3 languages. No A-level languages (foreign) will be considered. A candidate may pass two languages at HL/First language level.
- f) One of the languages should be a LOLT language.
- g) Obtained 40% in Senior Certificate HG subjects and 33,3% in Senior Certificate SG subjects;
- h) Obtained at least 30% in the NSC subjects.
- i) Older subjects with no grade should be considered as HG subjects. All maximum marks should be converted to 400.
- j) Satisfy the aggregate of 800.
- <u>Upscale max marks to 400</u> only in the case of Senior Certificate SG subjects and N3 languages for aggregate purpose only.
- 1) The <u>subminimum of 20%</u> will also apply for the 6<sup>th</sup> subject.

m) One subject condonation (max 2%) at 40% or 33.3% or 30% or 20% (where applicable according to policy) if the candidate is short of one subject to obtain the qualification or an aggregate condonation on 790 will apply. Condonations should be calculated on marks and not on percentages.
