RE-WRITE OF TOURISM PRACTICAL ASSESSMENT TASK (PAT): GRADE 12 NATIONAL SENIOR CERTIFICATE (NSC) 2022

- The Tourism Practical Assessment Task (PAT) was written on 27 and 28 July 2022 at 09:00. However, due to various valid reasons in the province, the PAT could not be written by some of the candidates.
- 2. The Department of Basic Education (DBE) will allow for a rewrite opportunity for Tourism PAT. The rewrite opportunity will be allowed for Grade 12 learners that were affected by the protest action, to valid reasons relating to illness, death and other special circumstances as stated in the Regulations.
- 3. In the case of candidates that will be allowed to write the Tourism PAT due to illness, death or other special circumstances, the candidate is required to provide validated documentary evidence. This opportunity must not be allowed for candidates that performed poorly in the first writing of the Tourism PAT.

- 4. The rewrite for the Tourism PAT is scheduled for 23 and 24 August 2022 from 09:00 to 13:00 on both days.
- The administration of the PAT will follow the standards set out in the Regulations pertaining to the Conduct, Administration and Management of the National Senior Certificate Examination.
- 6. The DBE will forward the marking guidelines for the rewrite Tourism PAT to the Provincial Examination Departments (PED) marking section to manage the marking guideline discussion and the marking with district subject advisors and the schools that are affected.
- 7. The marking of the PAT rewrite will be school-based and the learner evidence should be subjected to internal moderation within the school. The evidence should further be subjected to external moderation by the district subject advisors and the provincial Tourism coordinator before the marks can be accepted by the examination section.
- 8. All other instructions regarding the conduct of the Tourism PAT, as stipulated in Circular E9 of 2022 /Assessment Instruction 26 of 2022 must be adhered to in the conduct of the rewrite examination for the Tourism PAT.
