AMENDMENT OF THE SCHEDULED DATE FOR THE REWRITE OF TOURISM PRACTICAL ASSESSMENT TASK (PAT) DAY 2: GRADE 12 NATIONAL SENIOR CERTIFICATE (NSC) 2022

- 1. This Assessment Instruction has a reference to DBE Examination Instruction 32 of 2022.
- 2. The rewrite for the Tourism PAT was scheduled for 23rd and 24th of August 2022 from 09:00 to 13:00. However, it has come to the attention of Department of Basic Education (DBE) that there is a likelihood of disruptions in some parts of the country on the 24th August 2022.
