This correspondence has reference to Assessment Instruction no 21 of 2023.

- The above Assessment Instruction invited qualified applicants to apply **online** as markers for the Nov/Dec NSC Grade 12 examination marking. The closing date was the 28 April 2023.
- Loadshedding and other possible whirlwinds has interrupted the smooth running of some web-based systems including amongst others, online marker system. Even though applicants were advised not to wait for the last day/hour to submit applications, majority of applicants attempting to submit applications on the last day. The last moment rush and influx of applications at a go led to high traffic volume causing the system to run a bit slow and put a lot of strain on the server.
- Therefore, consideration has been made, the closing date for the submission of online marker application is hereby **extended to the 12 May 2023**.
- **Furthermore, applicants are urged not to wait until the last day**, to avoid traffic jam that may be caused by influx of many applications at once.
- *Kindly note that in the application form the space for qualifications is one mega bite (MB), therefore qualification documents must be compressed to fit that size using PDF compressor and or ancillary (additional) qualifications / senior degrees may*



not be included if the junior one inserted has the subject applied for at second- or third year level as per the requirements reflected in the Assessment Instruction.

- **NO** hard copies of application forms must be submitted and or accepted at all in district offices. You are even allowed to scan two pages of documents as one page to reduce the document size.
- **All Applicants/deserving educators will be supported in this process until they are all in the system. Please carefully read the Assessment Instruction 21 of 2023 and the guideline to successfully submit applications.**
- **All means possible will be made to ensure that NO educator is disadvantaged in any way.**
