INTRODUCTION

This Assessment Instruction deals with the registration of candidates for the 2023 National Senior Certificate (NSC) Examination. It outlines the categories of learners who may be registered by a registered school or a part-time district examination centre.

2. LEARNERS WHO CAN BE REGISTERED FOR THE 2023 NSC EXAMINATION

2.1 FULL-TIME LEARNERS

The Grade 11 promotion schedules were generated through SASAMS and were used to promote 2022 Grade 11 qualifying learners to 2023 Grade 12 full-time learners.



Please note that the applications for a change of One subject for 2023 Grade 12 Full-Time learners closed on 15 December 2022. (*Assessment Instruction 53 of 2022*).

2.2 FULL-TIME REPEAT CANDIDATES

- The Eastern Cape Department of Education affords all learners, who did not meet the requirements for the National Senior Certificate (NSC), an opportunity to return to school as full-time repeaters with them doing School Based Assessment (SBA), Orals and Practical assessment tasks (PATS) again in 2023.
- A memo from Acting DDG: IOM, dated 01 February 2023 on Re-Admission of Grade 12 Repeaters, contains details on the admission of this category.
- A learner must have written the National Senior Certificate Examination.
- Previous marks for SBA, Orals and PATS, for this category of learners are not carried over.

Please note that the applications for a change of One subject for 2023 Grade 12 Full-Time Repeat candidates closed on 10 February 2023. (*Assessment Instruction 09 of 2023*)

3. TRANSFERRED LEARNERS

3.1 The following categories of learners are referred to as Transferred Learners:

- Learners who met the promotion or progression requirements for Grade 11 in other schools or provinces and who are seeking registration as 2023 Grade 12 NSC candidates in new schools.
- Learners who attended the same school in previous years from 2008, fulfilled Grade 11 NSC promotion requirements but could not return to school and register for Grade 12.
- Transferred learners' verification form is attached as **Annexure A**.



3.2 REGISTERING A TRANSFERRED LEARNER

- A copy of the NSC Grade 11 report (compulsory) with contactable details and a transfer card **MUST** be attached to a transferred learner's registration form.
- No registration forms will be accepted by the district examination offices or the Provincial Office without these attachments.
- **It is the responsibility of the principal to verify the validity of the school report submitted by the new learner at his/her school.**
- The rate of fraudulent reports submitted by learners has drastically increased. Extra vigilance and care must thus be taken in the verification process.
- The validity of the documents of a transferred learner will also be checked by the District/Province on the promotion schedule of an Eastern Cape school.
- If the learner is from another province, the validity of the documents will be checked by officials in the relevant province.
- Principals are urged to inform parents of this process and to **register these learners provisionally** until notification of the finalisation of their registration in the 2023 NSC Grade 12.

4. REPEAT (PART-TIME) CANDIDATES

4.1 Learners who did not meet the requirements for 2008 – 2022 National Senior Certificate can register and improve one or more NSC subjects in 2023. To register as a part-time candidate for NSC in 2023, the learners must meet the following requirements:

- Learners must be in possession of a 2008 – 2022 NSC Statement of results issued by the National Department of Basic Education.
- This means that the candidate must have written the NSC examination between 2008–2022.
- Learners may only register for NSC subjects.



- Learners may register for one or more subjects.
- Candidates may change only one subject from those studied in the previous years provided that the candidate did not change a subject in his/her Grade 12 previous year(s) (**Please note that the applications for a change of One subject for 2023 Grade 12 Part-Time candidates were closed on 10 February 2023.**)
- **For the new subject to be registered, a candidate must register at a full-time registered centre for tuition in the new subject.**
- A written confirmation by the full-time registered centre to provide **SBA MUST** be attached to the registration form.

4.2 DOCUMENTATION REQUIRED TO REGISTER REPEAT (PART-TIME) CANDIDATES

- A South African ID book. This is compulsory, no candidate will be registered without it. Affidavits are not accepted.
- A part time registration form which will serve as a proof of registration must be completed in full (**Annexure C**).
- A copy of 2008 – 2022 NSC Statement of results.
- In the case of a candidate who has changed a subject, a letter from the Principal of a registered school that will provide tuition, assess and moderate SBA, Oral and PAT marks for the subject where no recorded marks are available, must be submitted.
- The candidate must agree to present himself/herself at the District Office to sign all preliminary entry schedules and to collect an admission letter to the examination that will give him/her access to the examination room.
- The District Office will issue the applicant with a proof of registration (**COMPULSORY**). (**Annexure C**).



4.3 INSTRUCTIONS TO PRINCIPALS

- Principals of schools are required to accurately complete the attached form on the analysis of candidate's numbers per subject and language version as part of the documentation required to complete the Grade 12 learners' registration process as well as printing of papers (**Annexure B**).
- Schools are informed that there will be no printing of dual question papers hence the language version of each subject has to be clearly indicated.

5. CLOSING DATES

- **Grade 12 Full-Time Repeaters: Wednesday, 15 March 2023.**
- **Grade 12 Transferred Learners: Wednesday, 15 March 2023.**
- **Part-Time Candidates: Wednesday, 15 March 2023.**

6. CONCLUSION

Examinations and Assessment Chief Directorate strives to administer examinations with zero defect. This can only be achieved if the registration of all candidates is error-free.

All Heads of Institutions are expected to disseminate this information widely to ensure that the class of 2023 can be resulted and be able to explore various opportunities of their choice.

- (a) An Identity Document in the case of South African citizens or a passport in the case of foreigners is compulsory. In the case of asylum seekers, the relevant supporting documents must be provided.
- (b) SNE learners and learners from ordinary schools must apply for special accommodations, if needed (e.g. large print, extra time, etc.).
- (c) No-fee candidates (candidates who don't need to pay school fees) qualify automatically for the "No Fee Status". Other candidates that need to be exempt from paying any related examination fees will need special approval and should apply at their school.
- (d) Certificate language – currently Umalusi only issues certificates in English. LOLT = Language of Learning and Teaching of the school.
