#### NATIONAL SENIOR CERTIFICATE (NSC): 2011 PROCEDURE FOR ADMINISTERING SCRIPTS OF UNREGISTERED CANDIDATES AT SCHOOL LEVEL

#### 1. BACKGROUND

All recognised candidates for the 2011 National Senior Certificate (NSC) and ABET L4 examinations have been registered on the official computer system of the Department of Basic Education.

Notwithstanding, year after year, persons not registered for the examination, or registered candidates who did not apply for a valid subject change, are permitted, by Chief Invigilators/Invigilators, to write subjects in these examinations.

Candidates/persons whose examination number does not appear on a computerised mark sheet on the day of the examination are <u>NOT</u> permitted into the examination room to write that particular subject.

The consequences of allowing an unregistered candidate/person into an examination venue include:

- The Chief Invigilator and invigilator may be charged.
- The results of the candidate who wrote the unregistered subject are incomplete.
- The results of the unregistered person are withheld.
- The media gives reports that reflect the Department of Education in a poor light, when the full responsibility and accountability for the problems rest with the Chief Invigilators and the Invigilators.

Principals, candidates and parents expect results to be released on time. For years irregularities have been ignored for the sake of the candidate. This cannot continue. Candidates receive an official Admission Letter indicating the subjects for which they are registered before the commencement of the examination. Not receiving an Admission Letter indicates that the person is not registered for the examination. The Department of Basic Education does not accept that officials and candidates in this Province continue to flout the regulations that govern registrations and subject changes.

Kindly note that learners who did not meet the promotion requirements for Grade 11 in 2010 cannot now be declared as an omission in error for the 2011 NSC examination. These learners were disqualified at the beginning of the year and were informed that they had to repeat Grade 11. **Do NOT permit unregistered** learners/people to write at the centre under your management.

# 2. PROCEDURE TO FOLLOW IN 2011 WHEN DEALING WITH ERRORS ON MARKSHEETS.

The mark sheets for orals, practicals and Practical Assessment Tasks (PATS) are an indication of the candidates registered on the system and the subjects for which they are registered.

If the school/ABET L4 centre discovers an administrative error on these mark sheets, this is to be reported to the District with relevant documentation as proof of the error. (Authorisation for subject change, copy of preliminary schedule, etc).

The District, with the assistance of the District Co-Ordination and IT Units at Head Office, will manage genuine errors in registration. An Additional mark sheet (on pink paper) with a validation code, supplied by the District Co-Ordination Unit, will be generated. These cases are not dealt with as irregularities and the marks should not be delayed.

#### 3. <u>PROCEDURE TO FOLLOW IN 2011 WHEN DEALING WITH A REGISTERED</u> CANDIDATE NOT ON A SUBJECT MARKSHEET.

This is not an error but, in most cases, an unauthorised subject change. If no proof of authorisation for the change of the subject exists, then no validation code will be given for the issue of a pink mark sheet.

This is an irregularity and will result in incomplete results for the candidate.

- The forms required must be on yellow paper and are available at the District Office.
- The forms must be completed at school level by the Chief Invigilator and others, as shown.
- An irregularity report (ANNEXURE 1) must be completed for every candidate not shown on the computer-generated mark sheet.
- A yellow mark sheet (ANNEXURE 2) must be completed for these candidates.
- Every detail on both the irregularity report and the yellow mark sheet must be completed.
- Both the irregularity report and the mark sheet must be placed in the script.
- The script/s must be returned in a separate script bag to the District Office.
- <u>DO NOT CONCEAL THE EXISTENCE OF AN UNAUTHORISED SUBJECT</u> <u>CHANGE BY PLACING THE SCRIPT WITH THE SCRIPTS AND MARK SHEET</u> <u>FOR ANOTHER SUBJECT.</u> (E.g. Placing a Mathematical Literacy script in a Mathematics script bag).
- THE SCRIPT WILL NOT BE MARKED AND NO RESULT WILL BE FORTHCOMING.

# 4. PROCEDURE TO FOLLOW IN 2011 WHEN DEALING WITH AN UNREGISTERED PERSON.

This is not an administrative error. An unregistered person does not appear on either the mark sheets or the system. No validation code will be given for the issue of a pink mark sheet. No mark will be released for this/these person/s.

# <u>These scripts should NOT exist as no person, who is not registered for an examination, should have been permitted access into the examination room at all.</u>

- An irregularity report (ANNEXURE 3) must be written for every unregistered person who was permitted to write the subject.
- A yellow mark sheet (ANNEXURE 4) must be completed for these persons.
- They will not have an examination number and will be using an ID number. Make sure that it is correct.
- They will also, in most cases, have no SBA and Oral marks, making their result incomplete before pen is put to paper!
- Every detail on both the irregularity report and the yellow mark sheet must be completed.
- Both the irregularity report and the mark sheet must be placed in the script.
- The script/s must be returned in a separate script bag to the District Office.
- DO NOT CONCEAL THE EXISTENCE OF AN UNREGISTERED PERSON'S SCRIPT BY PLACING THE SCRIPT WITH THE SCRIPTS AND COMPUTERISED MARK SHEET ON WHICH THE PERSON DOES NOT APPEAR.
- THE SCRIPT IS UNLIKELY TO BE MARKED AND NO RESULT WILL BE FORTHCOMING.

#### 5. <u>CONCLUSION</u>

Principals and ABET L4 centre managers are appointed to be Chief Invigilators during both the NSC and ABET L4 examinations. The District Office Examinations Unit trains all Chief Invigilators every year on the regulations, policies and procedures governing public examinations. The number of irregularities as a result of poor registration of candidates, permitting unregistered persons to write, allowing registered candidates to write subjects that they did not offer in Grade 11 nor received authorisation to change in 2011, have not declined.

No additional mark sheets should be permitted in the NSC and ABET L4 examinations at all. However, in the interests of managing the scripts, generated by these irregularities, at marking centres, it is imperative that procedures be followed.

Assessment & Examinations Directorates throughout the country strive for zero defect in examinations. In the Eastern Cape this will not be achieved until all stakeholders take registrations for public examinations seriously and do the work efficiently

You are urged to follow the procedures outlined in this Assessment Instruction to the letter.

Principals who will not need yellow Additional mark sheets are thanked for their hard work and congratulated on the efficiency of all involved in the registration process.
